Thank you for your interest in the Southwest Kansas Rifle and Pistol Club.

New members, or those renewing who have not previously completed an Orientation briefing, will need to meet with one of the club officers before being issued their membership card.

This is just to meet everyone face to face, make sure everyone is familiar with all rules and policies, and for legal accountability purposes. We no longer issues membership cards without meeting and informally vetting potential members.

These Orientation meetings will be 30 minutes or less, and you'll be contacted after receiving your completed application to arrange a mutually convenient time.

Please make sure you've signed and dated the membership application in the following places. Incomplete applications will not be processed:

- **Personal and contact information** (pg.3)
- **Affidavit of Eligibility** (pg. 3)
- **Disclaimer** (pg. 4)
- **Acceptance of Terms** (pg. 4)

Return pages 3 and 4 by either mailing them to the club at the address below, or bringing them to a meeting. After Orientation, you'll receive your membership card.

Please note that all range access and usage is now governed by the City of Liberal. SWKRPC no longer has the ability to provide access to the range to membership. All club members are subject to the same process for reserving the range in order to shoot as the general public. The club itself has nothing to do with range access or usage, aside from organizing shoots periodically.

Range access is possible only via reservation, by contacting the Willow Tree Golf Club via phone at or by walk-in. Note that the process involves filling out a "Usage Agreement" separately each time you wish to reserve and use the range. Range access if from 8:00 a.m to 8:00 p.m. daily, pending a reservation.

1. Joining:
 - a. Read through, fill out completely, and send in your application with applicable fees to:

 - b. New members or those renewing who've yet to attend one, will have to attend a Safety and Orientation briefing before being issued their final membership card and range combination. You will be contacted after we've received your application to arrange a meeting.
 - c. Members must meet the Affidavit of Eligibility requirements.
 - d. Members must provide a NRA Membership number on the application.
2. Staying Informed:
 - a. The club maintains a webpage where you can find a schedule of events, view current range reservations, upcoming club activities and events, as well as see score results and other information regarding club activities at www.swkrpc.org. This webpage is kept up to date with the most current information.
 - b. We also maintain a Facebook page, although it isn't constantly updated and doesn't necessarily contain all current happenings, at www.facebook.com/swkrpc
 - c. The club maintains an email address, which officers check regularly. You may contact us with questions or other concerns at swkrpc@gmail.com.
 - d. We do quasi-monthly newsletters, but electronically only. We will automatically include you in these if you've provided an email address in your application.
 - i. We will only provide a postal copy of these upon written request. To request a copy, write us requesting such to the address above in (1.a)
3. Range reservations:
 - a. All reservations for range usage are done through the City of Liberal, via phone 626-0175 at or walk-in to the Willow Tree Pro Golf Club.
4. Range Access and Usage:
 - a. The range is open from 8:00 a.m. – 8:00 p.m. daily, but only after having made a reservation via the city as per #3 above.
5. Guest usage:
 - a. You may bring guests with you to club events. Non-member guests will pay a 50% premium on any shoot fees.
6. Club meetings:
 - a. Club meetings are held twice a year. Members will be notified in advance of upcoming meeting dates. Check the website at www.swkrpc.org for current meeting times.
7. Membership dues.
 - a. Dues are currently \$20.00 per year.
